

### **PROHIBITIONS ON REDISCLOSURE NOTICE**

#### **AIDS OR HIV RELATED INFORMATION**

In the event that information released constitutes confidential AIDS/HIV related information protected under Connecticut law:

This information has been disclosed to you from records whose confidentiality is protected by state law. State law prohibits you from making any further disclosure of it without the specific written consent of the person to whom it pertains, or as otherwise permitted by said law. A general authorization for the release of medical or other information is NOT sufficient for this purpose.

#### **DRUG AND ALCOHOL ABUSE TREATMENT INFORMATION**

In the event that information released is protected by the HHS Confidentiality of Alcohol and Drug Abuse Patient Records Regulations:

This information has been disclosed to you from records protected by federal and state confidentiality rules (42 CFR Part 2). The federal rule prohibits you from making any further disclosure of information in this record that identifies the patient as having or having had a substance use disorder either directly, by reference to publicly available information, or through verification of such identification by another person unless further disclosure is expressly permitted by the written consent of the individual whose information is being disclosed or as otherwise permitted by 42 CFR Part 2.
